

Visitor Visa (TRV) and eTA

To study in Canada for less than 6 months, you must apply to Immigration, Refugee and Citizenship Canada (IRCC) for a Visitor Visa (also called a Temporary Resident Visa) or Electronic Travel Authorization (eTA).

Electronic Travel Authorization (eTA)

In most cases, you will require an **Electronic Travel Authorization** to enter Canada. This application is done online and costs \$7. You will need your passport and a credit card to complete the application.

The application requires this information: your name, date of birth, city, and country of birth, funds available for your stay in Canada, passport number and issue and expiry dates, email address, and residential address.

Temporary Resident (Visitor) Visa (TRV)

If you require a TRV, please follow these steps:

Application process

Apply online or in person at a Visa Application Centre (VAC).

Note: If you are required to submit biometrics (fingerprints), you cannot apply online; you must apply at a VAC: <u>http://www.cic.gc.ca/english/visit/biometrics.asp</u>

Complete and submit these forms with your application:

- Application for Temporary Resident Visa (IMM 5257)
- *Family Information* (IMM 5645) you must enter information about your parents, brothers, sisters and any children on this form; write **Not Applicable** if you do not have siblings or children
- Document Checklist (IMM 5484)
- *Schedule 1 Application for Temporary Resident Visa (IMM 5257 Schedule 1), if applicable. (<u>Most</u> <u>students will not require this form</u>. This document is required only if you answer "Yes" to any of the following questions: 3, 4, 5 or 6 in the "Background Information" section of the "Application to change of conditions, extend my stay or remain in Canada as a student" [IMM5709] form.

Supporting documents:

- You need to submit your *original passport* when applying for a Temporary Resident Visa (TRV).
- Find out if you are required to provide <u>biometrics</u> (fingerprints). Do **not** have your biometric fingerprints and photo taken before you submit your application. You can have your biometrics collected **after** you submit your application and have received a biometric instruction letter which will direct you to a list of points of service you may choose from; **or at the same time** as you are submitting your application in person at a Visa Application Centre (VAC).
- If you are not required to give biometrics, you must submit a passport sized photo (**digital** if you apply online; or **two photos** with your name and birthdate written on the back if you apply at a VAC).
- Acceptance letter from NSCC Registrar's Office
- Proof of financial support include any letters of financial support from a scholarship or from your parents; if your parents are funding your stay, include their bank statement
- Copy of your return flight plane ticket or itinerary

Pay the application fee (\$100.00) and \$85 biometric processing fee (if applicable). To find out how to pay, check the website of the <u>Canadian visa office</u> that serves your country. Fees are often paid by certified cheque or money order and may have to be paid in local currency.
